#### BACKGROUND

Pursuant to extended COVID-19 learning plan ("ECLP") legislation, thirty days after the approval of the plan ..., and every 30 days thereafter, ... at a meeting of the board or board of directors, ..." the Academy Board is required to take specific actions with regard to how instruction is going to be delivered during the 2020-2021 school year, solicit public comment, and publicly announce weekly interaction rates.

#### THE ACADEMY BOARD THEREFORE RESOLVES THAT:

1. The Academy Board is reconfirming that instruction shall be delivered as follows during the 2020-2021 school year:

Effective March 10, 2021, the Remote to Return students will return for in person instruction. The students who elected 100% virtual will continue.

The Academy Board, during this meeting, solicited public comment from the parents or legal guardians of the pupils enrolled in the Academy.
